SEO REPORT

Our Weather course has been on hold whilst our chief instructor gets his necessary repairs and cure for his ailment. Harry has been hurting with cellulitis and has involved at least 3 over-night hospital visits. We anticipate resuming instruction in January 2014.

Planning is underway for Advanced Piloting (AP). We will schedule following the completion of the Weather Course. Planning is also underway to schedule ABC3 classes. We anticipate a new demand for the public boating classes in light of the new NYS regulations requiring 8 hours of boating safety instruction which includes a proctored exam. (See the report on the law in last month's issue) The mandatory instruction and satisfactory exam grade is no longer for just personal water craft (PWC) operation. It is for all types of boat operation. It is structured so that the mandatory class includes youngsters for now and then everyone within a future time period. (With a birthdate after 1996 to start)

We have not seen the law but will obtain it and publish it in our next report. We have become aware that there are others that are offering the 8 hour ABC3 and New York State Boating Safety class in a single day. We find ourselves in competition with them in that we are losing participants and the opportunity to recruit members. (We note here that Utica Sail and Power Squadron has lost significant members. As of 6 DEC 2013 we have 48 "active" members.)

We have been discussing our "dilemma" at Council and Conference and have determined that other Squadrons are indeed having the same difficulty. Some Squadrons have begun to successfully offer ABC3 in one single day with successful results. Their technique includes a very structured script utilizing several instructors and USPS PowerPoint presentation. USPS is also offering several teaching aids that can be utilized by the Squadrons. We think it time to take a look at how we offer ABC3. We have a unique class in the spring that we feel is worth continuing.

However, we may want to consider either doing the whole 8 hour class in one day and include that unique feature or we might consider a two day class with the unique feature on day one with four hours that day and four hours the following Saturday. There are many variations but we do need to talk about it and plan our action.

Syracuse Sail and Power Squadron has notified us that they are preparing a flyer that will be handed out at the Syracuse Boat show that will include the dates for Syracuse's and Utica's ABC 3 course offering. We will try to get something together at our January meeting. Syracuse is also interested in joining Utica offering of Junior Navigation (JN). We will discuss that also at our next meeting. Syracuse at present does not have a JN or N instructor but have several interested in taking it even traveling to our area for the instruction.
